

# **Fact Sheet: PARKING AT THE SFVAMC**

*Parking on facility grounds is limited and at a premium. Use of public transportation and car/van pools are encouraged for all patients, employees and visitors.*

## **Registering Vehicles**

If you park on the grounds, you must register your vehicle with the Police and Security. You will be given a registration sticker to be placed on your vehicle. It must be placed in an area that is visible, i.e. bumper or rear window. Vehicles parked in an employee lot without a valid registration and payment of the daily, monthly or yearly permit will be subject to possible fines and/or towing.

## **Parking Fees and Restrictions**

All employees parking at the SFVAMC parking lot or garage must pay a parking fee. Paid parking will be required on all days of the week and for all shifts. The parking fee is subject to change based on reappraisal and review by the Department of Veterans Affairs. The same fee will be charged for trucks, vans, automobiles, motorcycles, motorized scooters or any other motorized vehicle. Employees parking in car/van pool or handicapped spaces must also pay the parking fee.

Daily fee:	\$1.00	Six-month permit:	\$75.00*
Monthly permit:	\$12.50	One-year permit:	\$150.00*

Daily parking permits may be obtained at the machine located in the parking lot. Monthly and Annual parking permits may be purchased at the Agent Cashier on the ground floor of Building 2. Parking permits must be visible and displayed at all times. Failure to display a valid parking permit will result in possible fines and towing.

*\*One-year parking passes are sold in January and are good for the calendar year.*

*\*Six month parking passes are sold bi-annually and are good for the first six months, and second six months of the calendar year. If purchasing an annual or bi-annual pass, keep in mind that fees are not prorated for months that have already elapsed.*

***Parking is provided on a first come, first served basis. Paying of parking fees is no guarantee of available space.***

Employee lots are designated as such and are on the west side of the Medical Center. Parking lots A and B are designated patient parking lots. Handicapped employees may park in lots B or E and must display a paid parking permit and appropriate state-issued handicap permit or tag. Parking lot C is designated for volunteers only. The bottom floor of the parking garage is reserved for handicapped, van/car pool parking. Please contact Police and Security for information regarding parking in this area of the garage.

Generally, vehicles cannot be parked on VA property more than 24 hours. Patients or visitors who must park more than 24 hours will require special permission through the Parking Committee.

## **Off Station Parking**

Employees who park on nearby streets must observe all restrictions regarding street cleaning days/hours, red zones, etc. Please be careful to not block the driveways of nearby neighbors.
